 Schaus' Swallowtail surveys: Our members participated in the on-going Schaus' Swallowtail survey, which is conducted annually in the Upper (Florida) Keys (April - June); this involved approximately 150+ hours of fieldwork by approximately 10 MBC members.

5. **Other:**

- a) **Restoration efforts:** MBC supported both financially and with "sweat equity" (volunteer hours) the restoration of the Calderon Pineland (Miami-Dade Co., environmentally endangered land) and the Girl Scouts' Camp Mahachee.
- b) Litigation: MBC has been involved as a co-plaintiff in a federal court action styled: The Center for Biological Diversity, et al v. U.S. Department of the Interior, et al., which challenged the (in) action of the National Park Service for its failure to "consult" with the U.S. Fish and Wildlife Service under the Endangered Species Act in connection with the Miami Wilds project (Richmond Pineland).

On December 11, the federal court granted our Motion for Summary Judgment, thereby vacating the 2022 agreement and release made between the National Park Service and Miami-Dade County (that agreement was executed to facilitate the Miami Wilds project). And as a result of the Court's action, the County is expected to declare the subject lease void.

On a related note, on the same day as the Court's opinion, the U.S. Fish and Wildlife Service sent a letter to the County which stated, in part, that all of the property which constitutes the "footprint" of the Miami Wilds project is considered to be "environmentally sensitive."
